What can you do if you disagree with a grant application decision?

For many applicants, the rejection of all or part of a grant application or the reduction of the grant often means that the case is closed. After all, the grant provider is a government, and 'you can't change much' about a government decision. Fortunately, in practice it is different.

## Contesting a government decision starts with a thorough check

A government decision can be challenged. That is the good news. But when it comes to grants, you have to be very alert. This is because grant law involves numerous separate decision moments: the decision on the application, an advance payment, an interim change, the determination, and even after the grant project has ended there may



be a decision relating to the recovery of excess funds received. Objections and appeals against these decisions are possible. But this only makes sense if it is done in time (the deadline is six weeks after a decision) and if there are valid arguments to challenge the decision. It is therefore of the utmost importance to check each decision immediately:

- has there been a miscommunication or other lack of clarity?
- are the facts correct?
- have the regulations and policies been correctly applied?

#### A good chance of success
